Change to Plastics Recycling

Since 2003, the City of Auburn has had ongoing discussions with its recycler, Waste Recycling, regarding the continuing downturn in the recycled plastic market. Over the past several years, the City has encountered difficulties identifying vendors to accept the City's plastic materials.

In order to make the City's collected plastics more viable on the recycling market, a change was made recently regarding the type of plastic products accepted as a part of the City's recycling program. As a result, **the City is currently only accepting those plastics bottles that bear the #1 or #2 recycling code.** The recycling code can be identified by looking at the bottom of each container inside of the triangular shaped emblem. Examples of those plastic containers that typically contain the #1 or #2 code are soda and water bottles, milk and other similar beverage containers, and liquid bleach and detergent containers.

In addition, the containers should be rinsed and cleaned prior to placing them out for collection or dropped off at our drop off center located on North Donahue Drive. The presence of plastic products other than those bearing the #1 or #2 code will contaminate the entire load that we deliver to the recycler. This will force the recycler to deem the load as non-recyclable.

Since the change went into effect, the City has received a number of inquiries regarding whether we will collect plastic grocery bags that bear the #2 recycling code. The City does not accept these bags as a part of its recycling program. We have contacted several local stores that distribute these bags to see if they will accept them. Both Wal-Mart and Winn Dixie stores indicated to us that they accept used bags that have been distributed by their respective businesses.

Are You Visible?

Citizens who bicycle, jog, or walk at dusk need to wear reflective material in order to be visible to automobile drivers. City Ordinance 1272 requires bicyclist, walkers, and joggers to wear reflective clothing from one-half hour before sunset until one-half hour before sunrise. This reflective material must be worn between the waist and shoulders on the front and back. In addition, all bicyclist must have an operating headlight on the front of their bicycles and reflectors on the front and rear spokes of the wheels and pedals.

These reflective materials must give indication of the presence of a bicyclist, walker, or jogger by the headlights of motor vehicles at a distance of a minimum of five hundred feet. Let's work together to make Auburn's roadways safe places for everyone.

Keep Your Family Safe

City law requires that house address numbers must be at least 4 inches tall and clearly visible from the road. This is important because, in some cases, mailboxes with house numbers are located across the street from the house. A parked car may block house numbers painted on curbs.



An improperly identified house may add precious seconds to a call for an emergency response. Help us help you by making sure your home is clearly addressed. The safety of your family may depend on it.
