## City to Hold Municipal Election on August 22

The City of Auburn's Regular Municipal Election will be held on Tuesday, August 22. Polls will be open from 7:00 a.m.-7:00 p.m. Voters will elect a Mayor at-large and five Council members in five voting wards. If no candidate receives a majority of the votes cast in the race for City Council members, a runoff election will be held on Tuesday, September 19.

#### City's Election Web Site - www.auburnalabama.org/elections

Any registered and qualified voter unable to vote at the polls on Election Day may apply for an absentee ballot if any of the following criteria is met:

- If you will be out of the county or the State on election day;
- If you have a physical illness or infirmity which prevents you from getting to the polls;
- If an elector works on a shift which has at least 10 hours which coincide with the hours the polls are open at his or her regular polling place;
- If you are enrolled as a student at an educational institution located outside Lee County and cannot get to the polls on election day
- If you are a member, spouse or dependent of a member of the armed forces of the United States in which case you may apply under the provisions of "The Federal Voting Assistance Act;" or
- If you are appointed as an election officer or named as a poll watcher at a polling place other than your regular polling place.

The City will accept applications for absentee ballots through Thursday, August 17. Applications for absentee ballots must be made in writing to the Acting City Manager and either hand-delivered or mailed to:

The application form must be signed by the applicant. Applications may be obtained from City Hall and must state the applicant's name, residence address, information necessary to verify the applicant as a registered voter, and the address to which the ballot should be mailed. Absentee ballots will be mailed to those persons who have made a proper application as soon as the ballots are printed. The completed ballot may be filed with the Acting City Manager and either hand-delivered or mailed to Auburn City Hall up to and including Election Day on Tuesday, August 22.

# **Auburn's Finances at a Glance**

One of the most visible indicators of a city's financial health is its bond ratings. The City of Aubum's bond ratings are Aa3 from Moody's and AA- from Standard & Poor's. What does a bond rating mean and how does it affect Aubum citizens and taxpayers?

A bond rating is similar to an individual's credit score, though it is determined in a different manner. Bond ratings are on an alphabetical scale, with C being the lowest and Aaa or AAA being the highest. A high rating indicates very strong creditworthiness. Just as in personal finance, a good rating leads to lower interest rates, which in turn saves taxpayer money. Monies saved through paying lower interest rates may be used for other worthwhile City projects for Auburn residents. Cities normally request a review of their bond rating before borrowing money in the national bond market. Auburn received its most recent bond rating in 2005 prior to a \$33 million bond issuance for school purposes.

Rating agencies look at a myriad of factors to determine credit-worthiness, including revenue trends, spending trends, reserve levels, debt levels, audited financial statements, the budget, long-term financial plans and management. In the most recent review of the City's bond ratings, the rating agencies reports cited their

reasons for assigning the Aa3 and AA- ratings:

"The Aa3 rating reflects continued diversification and growth of the city's economic base which derives a significant degree of stability from the presence of Auburn University. The rating is also based upon the city's strong financial position and manageable debt burden. The city's unemployment rate is consistently low as the city's economy continues to diversify. Economic activity has helped increase the size of the tax base, which has grown an average of 16% annually over the past five years. Moody's expects the city to maintain a sound financial position given conservative budgeting, strong financial management and the maintenance of ample levels of fund equity." ~Moody's Investor's Service

"The [AA-] rating reflects the city's economic base, which is dominated by the stable presence of Auburn University and the city's recent success in broadening the base beyond opportunities presented by the university; strong financial performance, coupled with sound reserve levels; and low overall debt burden, net of

self-supporting school debt. Compared to other Alabama municipalities, Auburn relies on a diversified revenue stream. With only 50% of its budget dedicated to wages, the city has sound expenditure flexibility. Strong revenue growth and expenditure control have allowed the city to maintain strong reserve levels. Debt levels are low and amortization costs are moderate." ~ Standard & Poor's



Auburn's bond ratings are among the highest in the state of Alabama, a signal that the City's finances are in good shape. Both rating agencies cited Auburn's economic development efforts as part

of the reason for affirming the excellent ratings. The City of Auburn, together with the Industrial Development Board (IDB) and the Commercial Development Authority (CDA), have undertaken dedicated economic development efforts over the past 20 years in order to accomplish two main goals:

- to provide good jobs for the region
- to grow the City's revenue base

Since 1994, more than 3,900 jobs have been created through the City's industrial recruitment efforts. Such jobs provide higher than

average salaries and good benefits for the employees and their families.

The new industries and commercial businesses locating in Auburn increase the City's revenues. These additional revenues are paid in part by the companies themselves through property taxes and business license fees, by the employees who are working in these new jobs through the occupation license fee, and by the

customers of these new industries, stores, and service businesses through sales and use tax. In fiscal year 2005, the various companies recruited and assisted by the City's economic development efforts provided direct revenues of over \$7.2 million to the General Fund.

In addition to these direct revenues, employees receiving paychecks from these companies then spend a significant portion of their pay at Auburn businesses, providing even more revenue to the City. Estimating the economic impact of the turnover of payrolls, the indirect revenue from these companies for fiscal 2005 is projected to be more than \$12.1 million. These additional revenues enable Auburn citizens to enjoy a variety of high quality recreational amenities, including parks and sports facilities, miles of sidewalks and bikeways, and a well-funded, nationally recognized and award-winning public school system. The City relies on its economic development programs to produce the revenues that enable the City to meet the expectations of its citizens that go above and beyond the basic services provided by city governments.

# Auburn's Sales Tax Holiday Weekend

At its June 6 regularly scheduled meeting, the City Council unanimously approved an ordinance authorizing Auburn's first ever sales tax holiday weekend. The sales tax holiday weekend will begin at 12:01 a.m. on Friday, August 4 and ends at midnight on Sunday, August 6.

Items exempt for the duration of the Sales Tax Holiday Weekend fall into 3 major categories:

- Clothing All human wearing apparel suitable for general use is exempt unless it otherwise appears on the taxable list; clothing items must cost \$100 or less per article of clothing to be exempt.
- Computers and Computer Software A single purchase with a sales price of \$750 or less will be exempt. Exempt items include computers, computer software, and school computer supplies.
- School Supplies Any items of \$50 or less per item commonly used by a student in a course of study will be exempt. Supplies may include art supplies, reference maps and globes, textbooks on an official school book list with a sales price of more than \$30 but less than \$50, and books with a sales price of \$30 or less per book. An all-inclusive list of exempt school supplies may be found on the City's web site at www.auburnalabama.org.

Items **not** exempt during the Sales Tax Holiday Weekend include:

- Clothing accessories such as handbags, jewelry, sunglasses, and umbrellas.
- Protective equipment such as breathing masks, hard hats, helmets, and safety belts.
- Sports or recreational equipment such as ballet or tap shoes, athletic gloves, goggles, or shin guards.
- Furniture
- Any systems, devices, software, or peripherals designed or intended primarily for recreational use.
- Video games
- Magazines, newspapers, periodicals, or any other document printed or offered for sale in a non-bound form.

# East University Drive Multi-Use Pathway Grand Opening
