

# August 2007 Highway 14 Multi-Use Path Grand Opening

# **Special Municipal School Tax Election To Be Held August 28**

At its June 5 meeting, the City Council adopted an ordinance authorizing the City of Auburn to hold an election on Tuesday, August 28 in which the citizens of Auburn will vote on whether or not to increase the Special School property tax



by 7 mills. As a result of citizen input, the increase, if approved, would be phased in over a period of three years. After analyzing the feasibility of phasing in the increase, Auburn City School officials determined that a phase-in will meet the needs of the schools and help lessen the immediate impact on property owners. If approved, the levy rate of the said tax shall be eight (8) mills for taxes that become due and payable on October 1, 2008 and 2009; ten (10) mills for taxes that become due and payable on October 1, 2010 and 2011; and twelve (12) mills for taxes that become due and payable on October 1, 2012, and on October 1 in each consecutive year thereafter.
