
Governor Riley Visits RecycleAuburn Drop-Off Center

Governor Bob Riley recently visited the RecycleAuburn Drop-Off Center, 365-A North Donahue Drive, to issue an update on grants from the Alabama Recycling Fund. These grants are designed to help municipalities and local organizations initiate or expand recycling efforts. During his visit, the Governor had the opportunity to tour the RecycleAuburn Center and noted its aesthetic qualities and convenient proximity to residential areas. The Governor commended City of Auburn staff and officials for their leadership and proactive approach to offering recycling programs. "Alabama

can and must encourage more recycling efforts like this," said Governor Riley.

In 1987, Auburn became the first city in the state to offer a municipal curbside recycling program. Today, more than 2,500 residences and commercial businesses participate in the weekly curbside program, and an additional 250 vehicles visit the RecycleAuburn Drop-Off Center each week. In 2008, Auburn citizens recycled more than 986 tons of commodities and diverted 8,863 tons of wood waste from landfills.

While Auburn's recycling programs continue to set the standard for communities across the state, City officials realize the importance of expanding the program. The 2009 Citizen Survey showed that citizens want to see additional emphasis on curbside recycling. Through the efforts of the Lee County Recycling Partnership, an intergovernmental alliance between Auburn University, the Cities of Auburn and Opelika, and Lee County, more than \$120,000 in grant funds have been secured from

2010 Citizen Survey Coming Soon

Auburn citizens once again have an opportunity to shape their local government by participating in the 2010 Citizen Survey, scheduled to get underway in January. The survey, now in its twenty-fourth year, plays an integral role in Auburn's interactive government. Results of the survey are used to set priorities and formulate the budget.

Last year's survey results identified two primary areas where citizens indicated they would like to see the City focus its attention:

- 1) the management of traffic flow and congestion and
- 2) the maintenance of City streets and facilities.

City officials responded to those requests with projects such as the East Samford Avenue extension to improve east-west traffic flow, improvements to the Donahue Drive – Magnolia Avenue intersection, the addition of pedestrian crosswalk countdown signals throughout downtown, and more than \$1 million in repaving, resurfacing, and restriping. Additional projects include renovations to the Frank Brown Recreation Center (FBRC) and preliminary plans for Phase II of the FBRC, including a Senior Center. In 2010, Abuturn citizens can expect to see the replacement of the North Donahue Drive Bridge, the Wire Road Bridge, the addition of a traffic signal at East Glenn Avenue and Airport Road, continued pedestrian improvements to the downtown area – including additional street lighting along West Magnolia Avenue, more pedestrian crosswalk countdown signals in downtown, and additional repaving and resurfacing projects.

Citizens who receive a survey in the mail are asked to take a few moments to complete the survey and return it in the postage-paid envelope. Telephone follow-up surveys will be provided for citizens unable to complete the survey by mail.

Auburn City Council Authorizes New Non-Exclusive Cable Franchise with Knology of Alabama, Inc.

At its November 3, 2009 meeting, the Auburn City Council unanimously approved an ordinance granting Knology of Alabama, Inc. a non-exclusive cable franchise in the City of Auburn. Immediately following the Council's authorization, Knology published a copy of the ordinance and franchise agreement, in accordance with Alabama law. Now that legal requirements have been met, Knology officials can begin preliminary engineering plans and capital expense allocations to locate infrastructure in Auburn. It will likely take Knology several years to build out an infrastructure that will allow them to serve a substantial portion of Auburn.

Political Sign Regulation Reminder

With the election year upon us, the City of Auburn would like to take a moment to remind citizens of regulations governing the placement of political signs in the City limits:



- Signs may not be placed earlier than 30 days prior to the election date. This includes signs for primary elections.
- Signs may not be placed in the public right-of-way, on any structures in the right of way (power poles, traffic signs, and medians), or on any property owned by the City of Auburn or Auburn City Schools.
- Signs are limited to a maximum size of 32 square feet.
- Signs must be removed within seven days following the election.
- It is the responsibility of the candidate to ensure that volunteers who distribute and install political signs are in compliance with these regulations.


